An Act to amend the Urban House Tax Ordinance, 1961

[1ST JANUARY, 1964]

ENACTED by the Parliament of Tanganyika.

1. This Act may be cited as the Urban House Tax Ordinance short title, (Amendment) Act, 1963, shall be read as one with the Urban House construction. Tax Ordinance, 1961 (hereinafter called the Ordinance), and shall and commencement come into operation on the first day of January, 1964.

2. Section 2 of the Ordinance is hereby amended by deleting the Section 2 definition "urban area" contained therein and substituting therefor the of Ordinance amended following new definition:-

3. Section 6 of the Ordinance is hereby amended by deleting sub-Section 6 of section (2) thereof and substituting therefor the following new sub-Ordinance amended section:-

"(2) In any other urban area the collector of urban house tax for such area shall be the clerk to, or other person who is the chief executive officer of, the district council within whose jurisdiction the urban area is situate.".

Section 15 of Ordinance amended

- 4. Section 15 of the Ordinance is hereby amended by deleting subsection (2) thereof and substituting therefor the following new subsection:—
 - "(2) Where under the provisions of section 4, urban house tax is levied in any other urban area, all such tax collected in any such area shall be paid to and form part of the revenues of the district council within whose jurisdiction the urban area is situate.".

Section 16 of Ordinance amended

- 5. Section 16 of the Ordinance is hereby amended—
- (a) by deleting from the second line of subsection (1) thereof the words "or town council" and substituting therefor the words and symbol ", town council or district council"; and
- (b) by deleting subsection (2) thereof.
