## An Act to amend the East African Common Services Organization Agreement (Implementation) Ordinance, 1961

## [5TH OCTOBER, 1962]

ENACTED by the Parliament of Tanganyika.

**1.** This Act may be cited as the East African Common Services Organization Agreement (Implementation) Ordinance (Amendment) Act, 1962, and shall be read as one with the East African Common Services Organization Agreement (Implementation) Ordinance, 1961 (hereinafter referred to as the Ordinance).

2. Section 2 of the Ordinance is hereby amended as follows: -

- (a) by re-numbering the same as subsection, (1) of section 2;
- (b) by adding immediately after the word "Ordinance" in the definition "the Agreement" and immediately after the word "Agreement" in the definition "the constitution of the Organization" as set out in subsection (1), as so re-numbered, the comma and words ", as amended from time to time";
- (c) by adding immediately below subsection (1), as so re-numbered, the following new subsection: -

"(2) Every amendment to the Agreement and to the Constitution of the Organization, together with the date on. which such amendment comes, or is deemed to have come, into operation, shall be published in the *Gazette* and laid before the National Assembly; and every such amendment shall, for the purposes of this Ordinance, come into operation, or be deemed to have come into operation, as the case may be, on such date."

**3.**-(1) The amendments to the Constitution of the Organization set out in the Schedule to this Act shall come into operation or be deemed to have come into operation on the dates specified in such Schedule as the operative dates for the respective amendments.

- (2) The validity of-
- (a) any act or proceeding of the Authority done before this Act comes in-to operation;
- (b) any Act of the Organization enacted before this Act comes into operation.

shall not be questioned in any court by reason only that it was not done or enacted in accordance with the provisions of the Constitution set out in the Schedule to the Ordinance if it was done or enacted in accordance with those provisions as amended in accordance with the provisions of the Schedule to this Act which, under this section, were deemed to have been in operation at the date of the relevant act or proceeding of the Authority or the enactment of the relevant Act of the Organization, as the case may be.

## SCHEDULE (Section 3 (1)) Amendments to the Constitution of the Organization **Operative Date** 1. For the words in Article 4 there shall be substituted the Ilth April, 1962 following: "The Authority shall consist of the Prime Minister of Tanga-nyika, the Prime Minister of Uganda and such Minister of the Government of Kenya as may be designated by that Government. 2. In paragraph 2 of Article 19 there shall be inserted, after 9th October, 1962. sub-paragraph (e), the following sub-paragraph-"(f) he becomes a Ministerial member of the Assembly'. 3. In Article 29, paragraph 2 of Article 30, paragraph 4 of Article 9th October, 1962. 30, and paragraph 2 (a) of Article 31 for the words "Governor of Kenya and the Governor of Uganda" there shall be substitu-ted the words "Governor-General of Uganda and the Governor of Kenya" 4. In paragraph 1 (2) of Article 42 there shall be inserted after the 9th October, 1962. words "Government of Tanganyika" the words ' and the Government of Uganda' 5. In paragraph I of Article 48 the definition of "the principal 11th April 1962 elected Minister" shall be deleted.
