



## NATIONAL ACTION PLAN FOR THE IMPLEMENTATION OF THE MARRAKECH DECLARATION, 2018 IN THE UNITED REPUBLIC OF TANZANIA

## Preamble:

We, the Participants of the capacity building workshop on the implementation of the Marrakech Declaration.

MEETING from the 3<sup>rd</sup> to 5<sup>th</sup> August, 2021 at Serena Hotel in Dar es Salaam in the United Republic of Tanzania;

**Recalling** the mandate of the Government of Tanzania in promoting and protecting human and peoples' rights in Tanzania under the African Charter on Human and Peoples' Rights;

**Reaffirming** the importance of the observance of the purposes and principles of the African Charter on Human and Peoples' Rights for the promotion and protection of all human and peoples' rights and fundamental freedoms for all persons;

**Taking note** of the African Commission on Human and Peoples' Right's Resolution ACHPR RES. 376 LX2017, in which the African Commission called on states to take the necessary measures to provide human rights defenders with a conducive environment to be able to carry out their activities without fear of acts of violence, threat, intimidation, reprisal, discrimination, oppression and harassment from State and non-State actors;

**Conscious** of the importance of the adoption of this draft national action plan in the context of Tanzanian history, constitution and relevant laws;

**Acknowledging** the important role of the cooperation of all Tanzanian national entities and the valuable work of individuals, groups and non-governmental organizations play in contributing to, the effective promotion and protection of human rights and fundamental freedoms of human rights defenders;

**Reaffirming** also the importance of the United Nations Declaration on Human Rights Defenders and the Marrakech Declaration, 2018 in declaring that everyone has the right, individually and in association with others, to promote and to strive for the protection and realization of human rights and fundamental freedoms at the national and international levels;

**Stressing** that all Tanzanian national entities shall play, jointly and separately, their solemn role to promote and encourage respect for human rights and fundamental freedoms for all without distinction of any kind, including distinctions based on, color, sex, language, religion, political or other opinion, origin, property, birth or other status;

**Adopts** this National Action Plan on the implementation of the Marrakech Declaration, 2018 expanding civic space and promoting and Protecting the rights of human rights defenders.
